Vice-Chairman Ellis Wood called the October Board of Public Safety meeting to order welcoming the Statesboro High School students and Southeast Bulloch High School students. Mr. Wood called on Governor Sonny Perdue to give the devotional. Vice-Chairman Wood then led everyone in the Pledge of Allegiance.

The following presentations were presented to the students of Statesboro High School and Southeast Bulloch High School:

Major Mark W. McDonough, Commanding Officer of the Georgia State Patrol gave a power point presentation on motorcycle safety and statistics for crashes worked in Bulloch County involving teenagers.

Deputy Director Rusty Andrews of the Georgia Bureau of Investigation spoke to the student body about Criminal History Records. Deputy Director Andrews stressed the importance of staying out of trouble and having a clean Criminal History Record.

Mr. Ray Higgins of the Department of Driver Services spoke to the student body about teenage driving laws.

Department of Corrections Commissioner Brian Owens introduced Mr. Cedric Taylor, Manager of Special Operations for DOC. Mr. Taylor introduced several members of the DOC Canine Unit who showed demonstrations with their canines in the search for drugs and explosives and also demonstrated an attack dog.

Vice-Chairman Wood called for approval of the September Board minutes. Chief Jack McElfish made the motion, seconded by Sheriff Steve Cronic and voted approval by the Board members.

## **DIRECT REPORTS**

Colonel W. W. Hitchens, Jr., Commissioner of the Department of Public Safety began by telling the Board members that MCCD Chief Mark McLeod would be retiring with 34 years of service, effective December 1, 2010.

Colonel Hitchens went on to advise the Board members that DPS would be presenting a resolution next month authorizing DPS to enter into negotiations with Monroe County for the construction of a new post for Post 44 - Forsyth which will be built on its current site. Colonel Hitchens stated that Post 10 - Americus was almost complete.

Colonel Hitchens stated the Governor's Annual Customer Service Awards were presented yesterday and that DPS had the most finalists up for the customer service awards.

In regards to the budget, Colonel Hitchens stated that the budget in 2009 was 118 million and has been reduced to 84 million dollars.

Deputy Director Rusty Andrews, Georgia Bureau of Investigation stated GBI had 242 sworn agents at this time, having lost 30 agents in the last year. Deputy Director Andrews advised at this time GBI is processing a small pool of eligible applicants to hire from in the event GBI is able to begin hiring agents next year.

Dr. George Herrin, Jr., Deputy Director for GBI Division of Forensic Sciences stated with the conditions that the GBI is working under, the Crime Labs are doing pretty well. Dr. Herrin stated that 40 people (30%) of those working in the Crime Lab positions are grant funded and GBI is working to try and get these people transitioned to state positions; while all the training is coming to a close by the end of the year or early January 2011. Dr. Herrin advised that the Toxicology Center in Augusta is up and running and GBI will see a dramatic improvement in the turn around. GBI has reopened the Moultrie Lab which is being used as a receiving lab. GBI is moving forward with the Moultrie Lab and the Columbus Lab.

Deputy Director Butch Beach, Georgia Public Safety Training Center stated the GPSTC Board report statistics are straightforward. The training continues to decline with most of it occurring off-campus. Deputy Director Beach went on to advise the Board members that the Governor's Public Safety Awards program will be held the second week in November and when the date is confirmed, invitations will be mailed out to the Board members. Deputy Director Beach stated that Colonel Hitchens and Director Kennan have been nominated to receive the Lifetime Achievement Award.
