The Board approved a Resolution authorizing the Commissioner of Public Safety to enter into negotiations with the City of Hazlehurst, Georgia, and to prepare and enter into the appropriate agreements and supporting documentation for the express purpose of developing appropriate contracts as necessary to enable the City of Hazlehurst to finance and construct a new State Patrol Post 16 facility on property owned by the City of Hazlehurst, Georgia, and, that upon completion thereof, to accept such property for use as State Patrol 16 as shall have been conveyed by reversionary deed from the City of Hazlehurst to the State of Georgia, and to thereby relocate State Patrol Post 16 from Helena, Telfair County, to Hazlehurst, Jeff Davis County, Georgia.

The Board approved a Resolution authorizing the Commissioner of Public Safety to enter into negotiations and the appropriate agreements and execute all contracts and supporting documents as necessary to: (1) enable the Department's custody of approximately 15 acres of land on Carl Vinson Road in Milledgeville Georgia from the Georgia Department of Behavioral Health and Disabilities; (2) construct new Post 33 facilities on said land; and (3) enable GSP Post 33 to temporarily occupy approximately 7,000 square feet of space within a facility owned by the Central State Hospital Local Development Authority, once the Authority has made the space occupant-ready and pursuant to a direct cost lease which shall end at such time as the new Post 33 facilities on Carl Vinson Road are ready for occupancy.
