DPS Resolutions

The Board voted to authorize the Commissioner of Public Safety to enter negotiations for converting the current short-term property lease of Georgia State Patrol Post 41 to a long-term lease.

The Board voted to authorize the Commissioner of Public Safety to enter negotiations for converting the current short-term property lease of Georgia State Patrol Post 26 to a long-term lease.

The Board voted to authorize the Commissioner of Public Safety to enter negotiations for converting the current short-term property lease of Georgia State Patrol Post 12 to a long-term lease.

The Board voted to declare no further use of certain facilities, which are in the custody and control of the Georgia Department of Public Safety and located on the 900 block of United Avenue S.E., Atlanta, and to authorize the demolition of those facilities for the benefit of future DPS law enforcement operations.
