#### **National Conference**

#### **Property Accountability**

We continue to focus on property accountability. Our three contractors---Mr. Travis Whitaker, Ms. Carla Govier, and Mr. Dave Stonehouse are assisting us with validating our inventory of Weapons, Aircraft, Watercraft, and Tactical Vehicles. Please confirm these inventory items and forward your front, side, and digital plate photographs to our office. This is a one-time requirement unless you change the paint scheme or in some way customize the equipment.

We have SUSPENDED

law enforcement agencies that have failed to conduct an annual inventory and we are currently in the process of TERMINATING several agencies. While this is problematic for those communities, surrounding jurisdictions will benefit from transfers. If you have inventory problems or issues, address them to your Regional Team.

#### RBI

The Reutilization Business Initiative (RBI) is moving forward. This system will replace the DRMS Automated Information System (DAISY)---the **DLA Disposition Services** property accounting tool--and it is also the entry point for requisitioning property. The tool you use to search for property "LESO Automation", will cease to exist on March 12, 2012. I do not know what the RBI property search application will look like as they are testing it right now. As soon as we have information, we will pass it to you. Be prepared for this change and be flexible.

## Eastern Region (Team Lead, Eastern United States - Mr. Dan Arnold)

### **State Coordinators and Law Enforcement Agencies**

In the first quarter of Fiscal Year (FY) 2012, the Eastern Team has conducted five Program Compliance Reviews (PCRs) in the following states: Maryland, Michigan, Ohio, Maine, and New Jersey. The remaining PCRs scheduled include Rhode Island, Mississippi, Louisiana, New York, South Carolina, West Virginia and Georgia.

In each state, LESO will be conducting a training session for as many Law Enforcement Agencies (LEA) as the State Coordinator can accommodate at the location. In the five states that PCRs were conducted in we have trained 301 officers representing 152 Law Enforcement Agencies.

Normally, the training is three hours and covers the basics of the 1033 Program: how to requisition property, how to pick the property up, property accountability, and program compliance. Let's discuss US Army TACOM weapons allocated through the 1033 Program. It is your responsibility, in accordance with the MOA you have signed with US Army TACOM to secure and account for them annually.

LESO has had several reports of weapons being stolen from houses, personally owned vehicles, patrol cars and even from some smaller police stations. If you have a US Army TACOM issued weapon, then you

must properly secure them. Failure to properly secure weapons, which results in a loss of accountability will result in unpleasant visits from DLA and ATF Special Investigators.

Please be responsible so that your career, your agency, and the 1033 Program is not jeopardized. Secure and account for your weapons, be responsible.

## Western Region (Team Lead, Western United States- Mr. Carlos Torres)

#### **State Coordinators and Law Enforcement Agencies**

The first quarter of the fiscal year has been busy with Program Compliance Reviews (PCRs) in Nevada, Arizona, Oklahoma, and Illinois. It's great to see all of the training and hard work paying off. The results of the PCR's have dramatically improved from the first time that our office has visited these States. Property accounting is much better and record keeping has drastically improved.

As we visit other states I am confident that we will see the same positive results. Some key things that will be reviewed during a PCR are:

1. Ensuring the State has a copy of all

receipts (DD Form 1348-1A), transfers, turn-ins, 103's, ATF forms, Air Craft Registration Forms.

- Ensuring the State
   has documented Law
   Enforcement Agency
   compliance reviews
   on file.
- Ensuring all of the Law Enforcement Agencies have a copy of the State Plan of Operations or State MOA.

This list is not inclusive, but contains some of the major items that are checked during compliance reviews. I plan on visiting Guam and Idaho during the remainder of the second quarter.

LESO is working with the Defense Logistic Agencies Video Strategic Communications Producer to update the current LESO Video.

Ms. Nutan Chada and her video production crew have already been to Illinois, Arizona, and Maine to shoot footage of property being utilized and to interview law enforcement officers that are active, supportive members of the 1033 Program.

LESO is planning on debuting this at the annual conference. We believe it will be a superb marketing tool for LESO and for all of you. The LESO team continues to work on process improvements that benefit the 1033 Program and to make your job easier and increase your ability to receive DOD technology, equipment, and supplies. As always we are willing and able to support you and your agency in their efforts to better police our nation.

## Aircraft/Watercraft Lead, (Mrs. Deborah Smith)

In December 2011, I attended the US Air Force Strike Board in Tucson, Arizona. I learned a great deal about the methods the US Air Force uses to "strike" aircraft from their records. I also spent a great deal of time with the US Air Force Item Manager. It was mutually beneficial for both parties.

In January, our Chief visited with the US Air Force Item Manager in Pentagon. We definitely strengthened our relationship in the first quarter of FY 12 with Air Force. As a result of this we have a better forecast

for aircraft availability. In June 2012 I plan to attend the next US Air Force Strike Board to further develop this relationship.

As a reminder, Federal. State and Local Law **Enforcement Agencies** interested in acquiring an aircraft through the 1033 Program are required to submit an Aircraft Request form to the Law **Enforcement Support** Office (LESO) Aircraft Lead. The Aircraft Request form is located at the following web address: https://www.dispositionser vices.dla.mil/rtd03/leso/air craftrequest.pdf.

Remember, aircraft acquired through the 1033 Program are to be used only for law enforcement purposes, including counter-drug and counter-terrorism activities.

## Eastern Weapons Lead (Mr. John Williams)

The Electronic Funds Transfer (EFT) is off to a good start. This efficiency began with List 175 and has considerably expedited the entire process. LEAs with weapons requested on List 174, which have chosen to make payments through EFT, have already begun to receive their weapons. That means Customer Wait Times have been reduced to two months after the receipt of the EFT checklist. We believe this entire process can be less than 60 days and we are continuing to drive the **Customer Wait Time** down.

Serial Number Verification Templates are only used after the receipt of new weapons from Anniston. Please do not put serial numbers of previously received weapons on the templates. Doing so causes delays in processing of the Serial Number Verification Templates due to having to research multiple databases to verify the serial numbers are not duplicated.

Recently, we have been receiving many requests for M4 rifles and M79 grenade launchers. Some incorrect information has been circulated to a few LEAs from unknown sources. The only information on weapons available through the 1033 Program should only be attained from this office.

There are currently only three weapons types available from TACOM through the 1033 weapons program:

- 1. M16A1 rifle, Caliber 5.56mm, 100% allocation.
- 2. M1911 pistol, Caliber .45, 100% allocation.

3. M14 rifle, Caliber 7.62mm, 50% allocation.

Please prepare your weapons request template accordingly.

We are tracking to have a historic year in weapon transfers to law enforcement agencies and at the same time our property accountability has been the highest yet.

## Tactical Vehicle Lead (Ms. Cassie Madden)

For those agencies that have taken the time to place their agency on the National Priority List for Armored Vehicles, it is paying off! This fiscal year we have already received 37 Armored Vehicles.

There were three different types of vehicles received: Pumas, Mambas, and CASSPIRS. The armored vehicles were all received at the Sierra Army Depot (California); however, future vehicles could be received at any location across the United States.

Seventeen different states will benefit from these vehicles which include: Alabama, Alaska, Arkansas, Arizona, California, Colorado, Illinois, Kansas, Missouri, New Mexico, New York, North Carolina, South Carolina, Tennessee. Texas, Virginia and Wisconsin.

Are you one of those states? Do you have a requirement for an armored vehicle? Place your agency on the priority list today as we never know what we may be receiving next week!

As other agencies that have received an armored vehicle will tell you, once vehicles are available, we move quickly. Please make sure you have preliminary approval prior to submitting your request to get on the national priority listing.

I look forward to seeing digital photos once these vehicles have been customized by your agency. Until then, please make sure to submit your front, left side, and data plate photos to complete the FY 2011 inventory.

## 1033 Program Success and Merced County Sheriff Office, CA (Ms. Hillary Ramos)

The Law Enforcement Support Office (LESO), whose primary function is to manage the 1033 Program, is very proud and honored to support and assist over 12,000 Law Enforcement Agencies (LEAs) that are enrolled in the 1033 Program.

One agency in particular, the Merced County Sheriff Office, has received two aircraft from the program: a Cessna fixed-wing Aircraft and a UH-1 "Huey" Utility Helicopter, which was most recently received on December 21, 2009. Both aircraft have been used in various law enforcement missions by the agency. Often, the aircraft are protecting and saving lives.

B.J. Jones, Operations Commander, is in charge of these aircraft. B.J. recently passed on to us that "we regularly and proudly use all of our aircraft". The Ops Commander recently sent into the LESO a success story that we are excited to share with you.

On Thursday, June 30, 2011 Merced County Sheriff's Deputies rescued five people from the swift, frigid water of the Merced River near Henderson Park, during an operation that lasted over 10 hours and included many tense moments.

The operation began Thursday afternoon when Merced County Sheriff's deputies received calls around 3pm about two individuals who had fallen into the river. The two individuals were rafting when suddenly their craft flipped over. Both individuals were able to

make it to the bank of the raging river. Thankfully, Deputies from the Merced County Sheriff's office were able to respond to the situation utilizing the aircraft they had received from the 1033 Program. The two rafters were lifted from the river's shoreline and taken to safety. Luckily, neither individual was seriously hurt.

The LESO is extremely motivated to assist LEAs in requisitioning property that is able to help them with their daily missions of protecting and serving the citizens of our great nation.
