Vice-Chairman Ellis Wood called the Special Call-in May 19<sup>th</sup>, 2014, Board of Public Safety meeting to order and said a prayer.

Vice-Chairman Wood held a roll call for members calling in.

Commissioner Mark McDonough, Department of Public Safety thanked the BPS members for attending the meeting and stated his business comes under the heading of strike while the iron is hot. Commissioner McDonough stated whenever DPS has an opportunity to build a new post; each one tends to be an adventure in and of itself. Commissioner McDonough went on to note this opportunity is no different; a very unique circumstance which has a lot of moving parts. Commissioner McDonough briefly explained Post 33 in Milledgeville was occupied around 1971, on twelve acres of property and what is unique about this property is that the DPS actually owns the 12 acres, not a normal circumstance with a normal relationship with a community that builds the post for us and then will have a long term lease. Commissioner McDonough added Central State Hospital has a large tract of land in and around Milledgeville and are actively looking to develop the land for positive purposes for the community. Commissioner McDonough stated the Resolution being presented by Ms. Crumpler is to be able to sell the property and to put the proceeds towards the building of a new post on a piece of property provided by Central State Hospital and one can see how unique this is. Commissioner McDonough noted Representative Rusty Kidd's presence, who represents the community as a state representative and is also on the State Properties Commission Board and in this circumstance we will have to do a lot of dealings and time with the State Properties Commission and having Representative Kidd on the Board and also representing the local community, it will be very helpful to guide DPS through this process.

Ms. Joan Crumpler, Deputy Director of Legal, Department of Public Safety presented a Resolution asking for approval of the BPS to authorize the Commissioner of Public Safety, in unison with the State Properties Commission, to enter into negotiations and make agreements with interested parties for the sale and temporary lease back of the headquarters and barracks of State Patrol Post 33 Baldwin/Milledgeville, contingent upon, in conjunction with, and by this Resolution further authorizing the Commissioner of Public Safety to take steps necessary to appropriate the proceeds of said sale to establish a new headquarters and barracks for State Patrol Post 33 in Baldwin/Milledgeville.

Sheriff Joey Terrell made the motion for the members of the Board of Public Safety to authorize the Commissioner of Public Safety to enter into negotiations with interested parties and, with the authority and approval of the State Properties Commission, to enter into the appropriate agreements and leases and execute all contracts and supporting documents as necessary to enable the sale and temporary lease back of the property located at 139 Highway 49, Milledgeville, Baldwin County Georgia, and further authorize the Commissioner of Public Safety, to negotiate and enter into such memoranda of understanding, contracts and leases and prepare other appropriate documents as necessary to take full possession and effective use of property for construction of a new barracks and headquarters with sale

proceeds, and to enhance public safety and conduct the operations of DPS and the Georgia State Patrol. This was seconded by Mr. Wayne Abernathy.

Mr. Wayne Abernathy asked Commissioner McDonough when the old post is sold, would there be enough money to cover the new post being built. Commissioner McDonough stated the anticipated amount as for as the value of the property at this time is right at a million dollars and hopefully with a donation of the property, no money spent on the property, money will be close for the actual post, maybe a little shy and will look to the local government to make up the final piece.

Mr. Lester L. Rampy, Jr., commented it looked like a win-win situation to him and Commissioner McDonough noted it is, but there are a lot of moving parts to this and this is the reason we chose to start today and then work with the State Properties Commission to move forward in order to get an authorization for a sale.

Representative Rusty Kidd stated he was concerned with the first paragraph on the second page in regards (from said sale for <u>all</u> costs associated with construction of the new headquarters and barracks) and knowing this would be the majority of costs, but did not know if <u>all</u> would tie the State Properties Commission into saying there could not be any extra costs down the road if the project costs more than what the sale of the property would be. Representative Kidd added it could be very easy that Georgia College wants the property and if Georgia College wants the property through the State Properties Commission, it might not generate a million dollars in hard cash and was concerned with the word <u>all.</u>

After much discussion to change the language from <u>all</u> to <u>most</u> and after conferring with Board Attorney Joe Drolet, it was decided to completely strike the word <u>all</u> from the first paragraph on the second page.

The BPS members voted unanimously to approve the Resolution after striking the word <u>all</u> from the first paragraph on the second page.
